The following supporting documentation is also required unless previously submitted and approved:-

- 1. Written confirmation from the Water Authority that the design of all surface and foul water sewers in the adoptable highway has been approved by them and that they are prepared to adopt them upon satisfactory completion.
- 2. Copy of discharge consent from the Environment Agency in respect of outfalls from any adoptable highway drains to existing ditches, watercourses, culverts or soakaways.
- 3. Supporting calculations for surface water disposal system.
- 4. Soakage Test results if soakaways are proposed for surface water disposal.
- 5. Where the lighting authority is the district or parish council, written confirmation from that authority that the design of any proposed lighting is acceptable to them and that they will be adopting the system upon satisfactory completion.
- 6. Copy of extract of Ground Conditions Survey to verify Design CBR (if available).
- 7. Design check certificates for any structures to be adopted as part of the highway. These must have been signed by the Council's Structures Section.
- 8. Please note that the developer will be required to provide the Council with a copy of the Health and Safety File as required by the CDM Regulations 2015 on completion of the Works.
- 9. One copy of the approved engineering layout at 1:500 scale or larger showing the adoptable areas shaded pink and the developer's land ownership edged in red.
- 10. One multi-coloured copy of the approved engineering layout at 1:500 scale or larger

showing carriageways in brown, footways in grey, block paving in yellow, verges in green, adoptable highway drainage in blue and lighting columns to be adopted by the Council or Parish Council in red.

- 11. Traffic Management: A £10,000 deposit to cover any emergency TM works
 - a. undertaken by BC during construction is required. (to be returned upon issue of the Final Certificate, if not used).
- 12. £5,000 upfront payment of the transportation fees. This is the minimum fee for all applications and will be deducted from the overall percentage based fees, if higher than this figure.
