STEERING GROUP TERMS OF REFERENCE

The steering group consists of a small advisory group meeting termly and a large stakeholders group meeting annually.

Membership of advisory group:

Members to be nominated by heads of service and to attend consistently:

- Chair of FACT Bucks
- SEND Youth Forum participation lead
- Service user- parent
- Service user young person
- Integrated SEND team area team manager/ SEND resolutions team
- School SENCO
- Early years SENCO or BC EY team
- College SEND representative
- Family Support
- Designated Clinical Officer
- Social care SEND representative
- SENDIAS team

Expectations of advisory group members:

- Attend termly meetings; send an alternative representative if unable to attend
- Respond to requests for advice in between meetings
- Be familiar with the national DfE approved Minimum Standards for IAS services.
- Read paperwork provided in advance of meetings

Purpose of advisory group:

The main purpose of the advisory group is to support the SENDIAS team leader to deliver the service. It will do this by:

Reviewing a termly report from the service, including the results of impact assessment and evaluations. The report describes how the service provides access to and ensures continuity of support from 0-25 through a 'dedicated and easily identifiable service' and monitor, reviews and rates the quality of the service according to the Minimum Standards for services providing impartial information, advice and support. This includes:

- upholding high standards of impartiality and confidentiality within the service
- ensuring that the SENDIAS Service maintains its "arm's length" status
- o identifying and promoting good practice
- o raising issues and concerns
- o identifying gaps and supporting the SENDIAS Service to address these.
- passing on the above information to relevant agencies
- having a formal mechanism for presenting this information to the local authority and relevant agencies
- o having a formal mechanism for the local authority and relevant agencies to respond to the above
- supporting prompt response by the service to feedback from service users and to national/regional/local developments and consultations
- Supporting the improvement of the service by contributing to a Business Plan.
- Promoting the independence and self-advocacy of service users.
- Raising awareness of the SENDIAS Service, in particular with own networks; to assist the SENDIAS
 Service in developing partnerships with, and communication between, all stakeholders
- Providing ongoing professional advice and guidance to the SENDIAS Service
- Ensuring value for money
