## **MURSLEY NEIGHBOURHOOD PLANNING REFERENDUM**

### **General Information for voters**



### **About this leaflet**

On **Wednesday 6 March 2024**, there will be a referendum on a neighbourhood development plan for Mursley Parish. This leaflet explains more about the referendum that is going to take place and how you can take part in it.

### **Referendum on the Neighbourhood Plan**

A referendum asks you to vote 'yes' or 'no' to a question. For this referendum you will receive a ballot paper with this question:

*'Do you want Buckinghamshire Council to use the neighbourhood plan for Mursley to help it decide planning applications in the neighbourhood area?'*

### **How do I vote in the referendum?**

You vote by putting a cross (X) in the 'Yes' or 'No' box on your ballot paper. Put a cross in only one box or your vote will not be counted.

If more people vote 'yes' than 'no' in this referendum, then Buckinghamshire Council will use the Neighbourhood Development Plan to help it decide planning applications in Mursley parish.

The Neighbourhood Development Plan once 'Made' (adopted) will become part of the Development Plan. In the former Aylesbury Vale District Council area, the development plan currently consists of the adopted Vale of Aylesbury Local Plan and the Buckinghamshire Minerals and Waste Local Plan 2016-2036.

If more people vote 'no' than 'yes,' then planning applications will be decided without using the Neighbourhood Development Plan as part of the Development Plan for the local area.

### **What is Neighbourhood Planning?**

Neighbourhood planning aims to help local communities play a direct role in planning the areas in which they live and work.

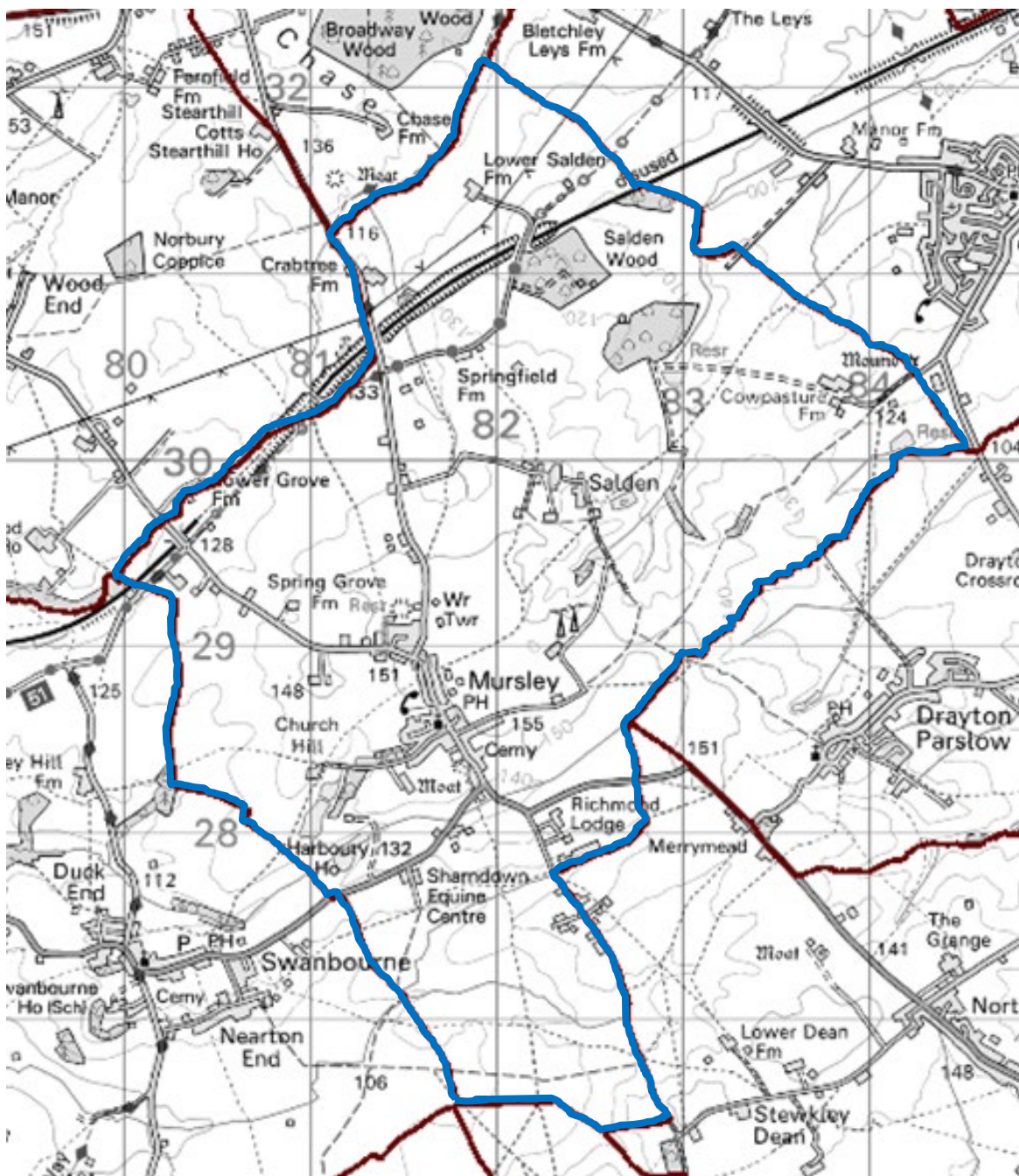
A community can prepare a neighbourhood plan. This plan can show how the community wants land to be used and developed in its area.

## What is a neighbourhood area?

A neighbourhood area can cover single streets or large urban or rural areas. The boundaries of a neighbourhood area are put forward by a parish or town council or a neighbourhood forum (a group of at least 21 people in areas without parish councils).

In Mursley Neighbourhood Plan, the boundary of the neighbourhood area was determined by the former Aylesbury Vale District Council and is identical to the parish area of Mursley (see below).

### **Who can prepare a Neighbourhood Plan?**

Neighbourhood plans are prepared by town or parish councils, or neighbourhood forums. In this case, the Mursley Neighbourhood Plan was prepared by Mursley Parish Council.

### **What is a Development Plan?**

In England, planning applications are determined by local planning authorities in accordance with the Development Plan. A Development Plan is a set of documents that set out the policies for the development and use of land across the entire local authority area.

### **Who is the Planning Authority?**

Within Buckinghamshire, the local planning authority is Buckinghamshire Council. Buckinghamshire Council is the lead authority for Neighbourhood Planning matters, including for carrying out Neighbourhood Planning Referendums.

### **Can I Vote?**

You can vote in the referendum if you live in the parish of Mursley and;

- You are registered to vote in local council elections, or you register to vote by Monday 19 February 2024. You can check if you are registered to vote by calling 01296 798141 or emailing [elections@buckinghamshire.gov.uk](mailto:elections@buckinghamshire.gov.uk)
- You are 18 years of age or over on **Wednesday 6 March 2024**
- When voting in person, you have a valid form of ID. To see which types of ID are valid or to get an ID for this referendum visit: <https://www.gov.uk/apply-for-photo-id-voter-authority-certificate>

The referendum will be conducted in accordance with procedures which are similar to those used at local government elections.

### **How to Vote**

There are three ways of voting:

#### **In person on Wednesday 6 March 2024:**

- Most people vote in person at their local polling station. It is easy and a member of staff will always be happy to help if you are not sure what to do.
- You will receive a polling card telling you where your polling station is, but you do not need a poll card to vote.
- You will need ID to vote, further details on how to get an ID and the types that are valid can be found here: <https://www.gov.uk/apply-for-photo-id-voter-authority-certificate>
- The Polling Station will be open from 7am to 10pm and is located at Mursley Village Hall, Main Street, Mursley, MK17 0RT

**By post:**

- To vote by post, you will need to complete and return an application form. You can apply to vote for post at: <https://www.gov.uk/register-to-vote>
- Completed applications for this election must arrive by 5 p.m. on Tuesday 20 February 2024.
- You should receive your postal vote about a week before polling day. If you have not received it in time, you can get a replacement up to **5pm on polling day**.

**By proxy:**

- If you cannot go to the polling station and do not wish to vote by post, you may be able to vote by proxy. This means allowing somebody you trust to vote on your behalf.
- To vote by proxy you will need to complete and return an application form. You can apply to vote by proxy at: [www.gov.uk/apply-proxy-vote](http://www.gov.uk/apply-proxy-vote)
- Completed applications for this election must arrive by 5 p.m. on Tuesday 27 February 2024.
- When you apply for a proxy vote you must say why you cannot vote in person.
- Anyone can be your proxy as long as they are on the Electoral Register and are willing to vote on your behalf. You do need to tell them how you want to vote.
